

## Terms of Use

These terms of our service govern our relationship with you as you engage, interact and consume our services. For all legal purposes this is a legally binding agreement between you (the student) and us (the company) and or our Partnered Companies.

By accessing or using the Site, the Platform, the Application or any of our Services you agree that you have read, and that you understand and agree to be bound by these terms and receive our Services ("Terms of Use" or "Terms"), whether or not you have registered with the Site and/or Application.

If you do not agree to these Terms, then you have no right to access or use the Site, Application, Services, or Collective Content (as defined below).

If you are using the Site, Application or Services then these Terms of Service are binding between you and WhizzCorps.

## **Definitions**

In addition to other words and expressions that may be defined elsewhere in these Terms, unless otherwise stated the context otherwise requires, the following capitalized terms wherever used in the Agreement shall have the meanings as ascribed hereunder:

- 1. "Assignments" means Campus Ambassador /Campus Influencer opportunities or tasks as listed on the Site or Application that a Student can register and apply for. Being a market-place these are offered by third parties.
- 2. "Content" means text, graphics, teaching materials, images, designs, charts, software (excluding the Application), audio, video, information or other materials.
- 3. "Campus Influencer/ Campus Ambassador, Student Affiliate" means a person, who completes WhizzCorps's account registration process.
- 4. "Partners or Clients" means our partners who are seeking services of Campus Ambassadors for activities such as Product Launch, Marketing and Promotions from Campus Ambassadors who have been shortlisted and deemed suitable for that project.
- 5. "Payment Method" means a payment method that you have added to your WhizzCorps account, such as a UPI ID, credit card, debit card or net banking. This can be through a third party.
- 6. In case of minor students the parent or guardian who enrolls their child or ward for the Projects via Application or Site.
- 7. "Workshop" means instructor led programs for a short period of time.
- 8. "Tax" or "Taxes" mean any taxes such as goods and services taxes (GST), or other such taxes as set up by the government the company may be required by law to collect and remit to governmental departments.

## 1. ACCOUNTS

You will need an account with us to access our services. Please ensure that your password is safe because all work related to your account is accessed via the login/password. If at all you think there is any suspicious activity on your account, please notify our support team immediately. We assume that all information you have provided at the time of opening your account is accurate and complete. We deem it your responsibility to ensure your information details as available with us are up to date at all times. Please expect to be verified by our support team before an interaction. Please be aware that we shall not be responsible for accounts that have been compromised due to callousness on the part of the student. As the owner of the Platform, we do not own, control, offer or manage any services on the Platform. You will be able to provide services to clients only on successfully completing your registration process. You may be required to provide additional details and documents based on the client's requirements of the service.

## 2. ACCESS RIGHTS AND PRIVILEGES

When a project has been made available to you as a Campus Ambassador, you are advised that it is purely for educational purposes. You (the student) are authorized to use the content, but this right is nontransferable and exclusive to the student. You are explicitly prohibited from any further distribution, broadcast, recording, sharing,

renting, creating any subset work, transmitting in hard or soft form without the written permission of WhizzCorps. We hold the authority to withdraw our services should there be a violation of our rights.

#### 3. NO EMPLOYMENT RELATIONSHIP:

You agree that you will be an independent contractor and not an employee of the Company or any Client who engages you via the Platform. You shall not represent directly or indirectly that you are an employee, or legal representative of Company. You shall not have the authority to incur any liabilities or obligations of any kind, in the name of, or on behalf of the Company. You acknowledge and agree that you are not subject to the direct control or supervision of the Company in relation to the services to be provided by you on the Platform. You do not have the authority to create, modify or terminate a contractual relationship(s) between the Company and any third party or act for or bind the Company in any respect. You recognize and agree that no joint venture or partnership agreement is intended or created hereby. The obligations performed under these Terms by you and the Company shall be on a principal-to-principal basis.

### 4. NO EMPLOYEE BENEFITS:

You acknowledge and agree that neither you nor anyone acting on your behalf shall be entitled to receive any vacation pay, sick leave, social security benefits, or any other employee benefits of any kind from the Company or any Client who engages you via the Platform. You agree, as an independent contractor, that you would not be entitled to any termination benefits/compensation payable under Indian laws in the event that you leave the Platform or your relationship with the Company or any Client who engages you via the Platform ends.

## 5. NON-EXCLUSIVITY:

You agree that you have entered into these Terms on a non-exclusive basis, and that both Company and you have the ability to enter into agreements for providing consultancy or services to third parties.

## 6. CHANGE OR APPLY FOR NEW PROJECTS

WhizzCorps allows you to change your projects only once using the following guidelines. Please refer to the Project Change policy document updated on our website.

## 7. INFORMATION SECURITY

When users of the Company's service use its products and they trust it with their information, it is the Company's duty to protect that information.
